Such actions are proposed to occur within Land Under Waterbodies and buffer zone to Inland Bank associated with Pontoosuc Lake. The applicant is Pontoosuc Lake Properties, LLC.
- B. File #19-11- Request for Determination of Applicability for the removal of trees and miscellaneous woody debris on property located at 137 Elaine Drive (Map M8, Block 1, Lot 26). Such work is proposed to occur within buffer zone associated within Bordering Vegetated Wetlands. The applicant is Paula Daily.
