- 1. **Public Hearing** An application from Bosquet Sport Enterprise, LLC for a special permit under Section 7.823 (parking area in a residence district), Section 10.212 (reduction of loading spaces), and Section 10.110f (reduction of the number of formal paved parking spaces) related to the alteration and expansion of the pre-existing fitness club located at 100 Dan Fox Drive. The property can also be identified as assessor map numbers G3-1-2, G3-1-3, and G3-1-201.
- 2. **Site Plan Review** An application from Jamasan Hotel Management for site plan approval under Section 7.839 (eating establishment drive-through) to allow for the construction of a proposed coffee shop with a drive-through at 1030 South Street. The property was formerly in-use as an auto-service station. The property can also be identified as assessor map numbers H1-1-3 and H-1-1-6.
- 3. **Public Hearing** An application from Berkshire Housing Development Corporation for a special permit approval under Section 7.715 of the Zoning Ordinance to construct a 3 story 28 unit multi-family residential building at 107 and 111 West Housatonic Street. The application also includes a request under Section 10.110f to reduce the number of required off-street parking spaces. The property can also be identified as assessor map numbers H8-1-23 and H8-1-22.
